## WHAT WE DO

Florida Philanthropic Network connects Florida grantmakers to one another through educational programs, networking, regional convenings, online opportunities and much more.

We provide news, information and resources to the philanthropic community in Florida, advocate on behalf of philanthropy locally and nationally, and commission objective research on the nonprofit and philanthropic sectors.

FPN conducts regular research on Florida philanthropy and grantmaking, as well as periodic research on the state's nonprofit sector, to help inform the work of people working in the field or with the field.

## WHY WE DO IT

Complex problems demand dynamic solutions. Florida Philanthropic Network believes that systemic change will occur through collaboration, cooperation, education, research and sound public policy. If we combine forces, we will build a unified voice for the nonprofit sector in Florida that will advance this theory of change to improve the quality of life for all Floridians.

## MEMBERSHIP CRITERIA

To qualify for FPN membership, an organization's principal function must be the making of grants for charitable, religious, educational or scientific purposes, and its annual grant distributions must be made to multiple organizations that are not subsidiaries of or related to the grantmaker, rather than to one institution.

In addition, a grantmaking public charity must operate a competitive grantmaking program and commit more than 50% of its annual expenditures to such a program.

## MEMBERSHIP TERMS

Dues are applied to FPN membership from January 1 — December 31 of each calendar year, with membership renewed at the start of each calendar year. For new members, membership dues are prorated for the first year based on the month joined.

For example, an organization joining in March would pay 9/12 of its full membership dues for the first year.

## NON-SOLICITATION POLICY

Since a vital role of Florida Philanthropic Network is to provide an opportunity for grantmakers to meet in a collegial and respectful atmosphere, all FPN members understand that it is not appropriate to solicit donations at FPN programs, events and other functions. Collaborative grantmaking, however, is to be encouraged.

Organizations that have a dual grantmaking and grantseeking role agree that their development staff will not utilize FPN activities or resources for fundraising/development purposes.
